

Dataset Terms of Use

Note that this document is not a proposal for conclusion of a contract — in order to obtain rights to use the Dataset, a contract between You and the Licensor must be closed and formalized in the form of a contract first. This document only summarizes the Terms of Use and outlines the licensing. To proceed with the contract, visit our website (www.verifee.ai/research) and request access.

Verifee Research (hereinafter "Licensor"), composed of Matyáš Boháček, Michal Bravanský, and Filip Trhlík (hereinafter "Authors"), strive to enhance public access to and use of the data whose collection, annotation, and publication they executed. The data (Czech news articles with information regarding their manipulative attributes) are organized in a dataset (the "Dataset"), presented at https://verifee.ai/research (the "Website"). The Dataset is a collection of data, managed by the Licensor and provided in several machine-readable formats.

Licensor provides any individual or entity (hereinafter "You" or "Your") with access to the Dataset free of charge subject to the terms of this agreement (hereinafter "Dataset Terms"). When You download or use provided Dataset, You are agreeing to comply with the terms of CC BY-NC-SA 4.0, including strict ban
